### Rules and Regulations

1. Check-in time is 6:00 AM to 8:30 AM on the day of the event. We will consider yours a vacant space, available for last-minute assignment if check-in is not complete by 8:30 AM.
2. Set-up time begins at 6:00 AM on the day of the event. All set-up MUST be completed by 9:30 AM. Vehicles may be left on site. (Cars / Small SUVs only)
3. Vendors are expected to use good judgment in their choice of wholesome merchandise. NO suggestive or obscene T-shirts or other items should be displayed where children might possibly see them.
4. No knives or others weapons may be offered to children.
5. No nuisance items may be sold or given away (such as silly-string or other littering items, caps, exploding devices, or noisemakers, and, of course, no fireworks or other illegal items).
6. Please conduct your business in the friendly, pleasant way. The Hampstead Volunteer Fire Company reserves the right to eject any vendor who conducts business in a manner we consider fraudulent or objectionable. We also reserve the right to reject any application.
7. We suggest that you see to it that your space/table is attended at all times. We are not responsible for accidents or loss. Take care that you do not set up your space/table in any manner that might be dangerous (e.g. people falling over tent stakes, booth collapsing in a breeze). The Hampstead Volunteer Fire Company, and its members, shall not be responsible for any injuries or damage caused by or to any guest, agent, employee or invitee of the vendors, and

I understand **that there is no rain date** for Fall Festival and that **I will not receive any refund** (full or partial) if the event is rained out or cancelled for any reason. I have received a copy of the terms and conditions governing Fall Festival vendors and agree to comply. Failure to comply will result in immediate **removal from the festival without a refund and banning from future Fall Festival participation. I affirm that I subscribe and agree to** all terms, conditions, and authorizations contained in this agreement.

The vendor agrees to hold Town of Hampstead, Maryland, the Mayor and Town Council of Hampstead, the Hampstead Volunteer Fire Company, their officials, agents, and members, and sponsors harmless from any and all liability arising out of Vendor's participation in 2018 Hampstead Volunteer Fire Company Fall Festival.

Complete this agreement and return with check or money order made payable to Hampstead Volunteer Fire Company on or before October 1, 2018. (NOTE – There is a \$25.00 fee for returned checks.)
